Lawsuit Filed Against SharkNinja Over Dangerous Blenders & Pressure Cookers

Bernheim Kelley Injury Lawyers Investigating Nationwide Claims of Injury from SharkNinja Blenders & Pressure Cookers

FORT LAUDERDALE, FL – April 22, 2025 – Bernheim Kelley Injury Lawyers has filed a product liability lawsuit against SharkNinja Operating, LLC, in connection with injuries caused by a defective Ninja blender. The lawsuit alleges that the product's faulty design resulted in serious bodily harm. The firm's experienced mass tort trial attorneys, based in Massachusetts, are actively investigating similar claims regarding injured consumers across all 50 states.

The lawsuit stems from a serious incident involving a New Jersey woman who suffered significant injuries while using her SharkNinja blender. According to the complaint, the plaintiff was using her blender on February 7, 2021, when the blade detached from the base, causing scalding hot contents to be forcefully ejected onto her. She suffered serious bodily injuries, physical pain, and mental anguish, resulting in diminished enjoyment of life. The plaintiff seeks compensatory damages to cover her medical expenses.

The lawsuit further alleges that NutriNinja blenders are unreasonably dangerous because they are designed without proper safety mechanisms, such as pressure relief features or clear pressure indicators. As a result, users may unknowingly be exposed to dangerous pressure buildup and risk sudden explosions of hot contents—even during ordinary use.

According to the complaint, the company ignored and/or concealed its knowledge of the defects in order to protect its profits. This demonstrates what the lawsuit describes as a callous disregard for public safety.

As SharkNinja products are sold in most major stores, these dangerous defects and the resulting injuries to consumers must be addressed, and the manufacturer must be held accountable.

“Our client trusted this product was safe, but instead, ended up in the hospital with serious, preventable injuries,” said Walter Kelley, a managing partner at Bernheim Kelley Injury Lawyers. “We believe that SharkNinja had a responsibility to make sure their products met basic safety standards—and they failed to do so. We want them held accountable and for victims to receive the compensation and justice they deserve.”

SharkNinja blenders and pressure cookers have been reported to malfunction due to flaws in the blade assembly and sealing mechanisms. In some cases, the blade assembly can detach during use, causing sharp blades to be ejected and resulting in deep cuts and lacerations. In cases where the pressure buildup inside the blending container causes explosions of hot contents, consumers may suffer severe burns and other injuries. These hazards extend to anyone nearby, not just the user.

“It’s unacceptable for products marketed as safe to be putting people in the hospital,” added Jesse Bernheim, CEO and Trial Attorney at Bernheim Kelley Injury Lawyers. “No one should have to suffer because a company may not have taken the necessary steps to protect consumers from the dangers of their products. We’re committed to holding them accountable and hope to save others from the same trauma.”
