**Major Food Companies Facing Lawsuits Over Child Health Risks Linked to

“As parents, we do everything in our power to keep our kids safe. You never imagine there are dangers sneaking into our homes in their food. But here we are, with many kids suffering lasting harm,” said Jesse Bernheim, CEO and Trial Attorney at Bernheim Kelley Injury Lawyers. “These families deserve answers and accountability. We are investigating these cases to help parents understand that they may have legal options.”

The health risks associated with UPFs are significant.
